 Adoption of Minutes: It was moved by Kathi Tucker, seconded and unanimously passed to approved the April 2 minutes as amended.

Officer Reports:

President: Steve Jacobs:

- · Policy Revisions
 - Benton County Policies and Procedures section 5.2. Awards and Recognition: It was noted the behind the scenes award is not mentioned in our Policies and Procedures document. Meleah will work on a revision.
- G2 (aka mini college) Raffle and Silent auction: OMGA is requesting that each regional association contribute 10 or more items with a minimum value of \$25. Debbie Wray has the lead: (Due end of June.)
- Paper copy publications storage in extension office: A discussion was held regarding the
 paper copy circulars kept in the extension office and whether they should be retained. While
 most documents are on line, some of the circulars have been archived without being updated.
 In those cases, we have relied on the paper copies to provide clients with information. (An
 example is the publication on managing moss in lawns). Volunteers offered to inventory the
 paper publications and scan those we want to keep. Brooke Edmunds requested we work
 through her to resolve issues with any publication that we feel we need that have been
 discontinued.
