AMENDMENT TO LIFE TIME MEMBER AWARD

Current Language:

<u>Lifetime Members</u> – are members selected by the Board of Directors who have significantly contributed to BCMGA programs and activities, have accumulated and recorded a minimum of 1,000 volunteer hours by the time of the nomination, or otherwise meet criteria established by the Board...

Approved revised language:

<u>Lifetime Members</u> — The Board of Directors may select members who have significantly contributed to BCMGA programs and activities for the Lifetime Member award. Nominees should be certified at the time of nomination and have accumulated, and recorded, a minimum of 1,000 volunteer hours by the time of the nomination, have served in a leadership capacity (Board service or committee Chair) and have consistently contributed significant volunteer hours (over 100 hours annually). The Board may also establish additional criteria. Lifetime Member awards should be limited to one per year except where there are extraneous considerations, as determined by the Board of Directors....
