Secretary: (Deb Kern)

- Plant Problem Scenario update: We will be conducting six plant problem scenario sessions for the 2019 Master Gardeners class. Mentors are encouraged to participated in these sessions.
- Demo Garden Educational Structure: Deb shared the demo garden committee's
 proposal to build an educational gazebo like structure at the demo garden located at the
 Benton County fairgrounds. Brooke and Elizabeth suggested the committee apply to
 OMGA Extension Educator grant, and OSU Folk Club grant. Sophie suggested any
 grant request include a statement that it will be ADA compliant.
